

## Vodafone 6GB Terms and Conditions

1. The 6GB Internet Bundle ('Bundle') is offered by Vodafone Malta Limited ('we') under these terms and conditions ('Specific Terms and Conditions').
2. You may subscribe to the Bundle as from the 5th November 2018. This version of the Specific Terms and Conditions is applicable as from 5th November.
3. These Specific terms and conditions form an integral part of your Agreement for the provision of the services included in this Bundle. These Specific Terms and Conditions constitute a legally binding contract between you and us and must be read in conjunction with (i) [Vodafone General Terms and Conditions](#), (ii) [Vodafone Secure E-Billing Service Terms and Conditions](#), (iii) [Rest of World Vodafone Traveller](#), (iv) [Quality of Service term](#), (v) [4G Service terms](#), and any other terms and conditions that might be referred therein. In the event of a conflict between any of the terms, the applicable precedence shall be the order in which the terms are mentioned in this term 3 (highest level of precedence first).
4. Vodafone reserves the right to limit the number of the Bundle/s offered to a single person/legal entity.
5. Should you require any assistance; you can call our Customer Centre by dialling 247 for free from your Vodafone number. Alternatively, visit any one of our retail outlets or speak to us on our live chat.

### Bundle and Price

#### 6. The Internet Bundle:

**6.1** All rates and charges quoted below are inclusive of VAT but are exclusive of excise tax or any other taxes which may be applicable.

**6.2** You can benefit from the 6GB Internet Bundle at a price of € 19, upon successfully signing up by using one of the methods described in term 9 below, followed by successful top up with at least €20 or more.

#### 7. 6GB benefits:

**7.1** When benefiting from the 6GB Bundle you will get 6GB of data allowance which can be used locally and also whilst roaming in the EU.

**7.2** The data provided is valid for 4 weeks (for the avoidance of doubt, 28 days) and any unutilised data shall be not carried forward and forfeited unless you top up with at least € 20 within the 4 weeks' window. The data carried forward will be accumulated until you stop benefiting from the 6GB Internet Bundle as further described in term 7.3 below. Vodafone reserves the right to stop the accumulation of data allowances in accordance with term 11.2 below.

**7.3** Any remaining MB shall not be carried forward and forfeited if you unsubscribe and move to other bundle or any other prepaid plan or if the top-up is done after expiry of the 4 weeks' window. Upon the expiration of the 4 weeks' period you will receive an SMS notification whereby we inform you that the 6GB Bundle have

expired. For the avoidance of doubt this does not apply to any credit left in your account.

**7.4** If all data provided within 6GB Bundle are used up or forfeited, you shall be charged according to the following Out of Bundle data rates:

**Out of Bundle Rates (Local and EU)**

**Data:** €0.99 per 200MB valid for one (1) calendar day will be applicable. Any remaining unutilised MBs shall not be carried forward upon the expiration day time-window, for the avoidance of doubt it is valid from 00:00 to 23:59 of the same day when the charge is triggered. This Out of Bundle rate will commence once all the data allowance within the Plan is consumed and will continue to recur until a totality of 6.25GB. Any data above this limit will be charged at the rate of 2c/MB, unless you purchase an Add-On Bundle in accordance with term 9 below.

**7.5** You can monitor your usage by sending a blank SMS to 16290 from your mobile phone free of charge. You are hereby being advised that this only serves as guidance as it may not always be accurate. Therefore, should you exceed the data allowance in your Bundle, you will still be liable for all access charges.

**7.6 Roaming.** You can benefit from 6GB Internet Bundle whilst roaming in the EU as described in in this term 8.1. above. The EU roaming benefits provided with this Bundle are subject to the Fair Use Policy in line with the EU Regulations further explained under Term 13.2 of [General Terms and Conditions](#). Whilst roaming outside of the EU the data will not be consumed from the Bundle, kindly refer to [Rates by Country](#) for more information on charges when roaming outside of the EU.

**8. How to benefit from 6GB Internet Bundle:**

**8.1** In order to benefit from 6GB Internet Bundle, you need to:

**8.1.1** successfully sign up by using one of the methods described in term 9 below

**8.1.2** successfully top up your account with at least €20 or more.

**9. How to sign up to 6GB Internet Bundle:**

<b>Sign up</b>	by logging in to My Vodafone Account using <a href="#">My Vodafone App</a> . <b>OR</b> by logging in to My Vodafone Account using My Vodafone Web <b>OR</b> Sending a SMS to 16200 from the Mobile number you wish to subscribe, writing <b>6GB</b> <b>OR</b> Visit one of our retail <a href="#">stores</a> or call us on 247 from your handset.

**9.1** Upon signing up to 6GB Internet Bundle, we shall send you a verification SMS confirming your successful subscription. You will be automatically switched on to 6GB Internet Bundle upon such confirmation.

**9.2** Upon subscribing to 6GB Internet Bundle and topping up as described in term 8, you will automatically lose any unused benefits that you were benefitting from your previous plan.

**9.3** In the event that you use data before receiving the SMS notification confirming your successful subscription and prior to topping up with up at least €20 or more to 6GB, you shall automatically be charged according to the plan you would be subscribed to prior to this subscription.

**9.4** The 6GB Data allowance will be assigned once a successful top up with at least €20 or more is completed. You will benefit from 6GB Data allowance each time you top up of € 20 or more, unless you unsubscribe in accordance with term 11 below.

## **10. How to unsubscribe from 6GB Internet Bundle:**

**Unsubscribe** Send an SMS with ' **STOP6GB** ' to 16200

**10.1** You may unsubscribe from 6GB Internet Bundle at any time without forfeiting the unused data until their original expiry date. However, should you subscribe to another plan whilst benefiting from 6GB Internet Bundle, the 6GB Data allowance will be forfeited as explained in term 7.2 below.

**10.2** You may only benefit from one (1) prepaid plan or recurring bundle at a time. If you decide to subscribe to any other prepaid plan offered by us or to any Top Up and Get plan or add-on bundle that is not compatible with this 6GB Internet Bundle, whilst being subscribed to this Bundle, you shall automatically stop benefiting from the 6GB Internet Bundle and you will lose any unused Data allowance.

## **11. General Information on this Bundle**

**11.1** When you subscribe to this Bundle, you are automatically accepting to adhere to these Specific Terms and Conditions.

**11.2** We reserve the right to suspend indefinitely or for a definite period, amend/alter/delete or terminate these terms and conditions at any time (collectively the 'Modifications'), by giving you a 30 calendar days' prior written notice with the proposed amendments/alterations or stating the reason for the Modifications thereof. Should you disagree with the proposed Modifications during the 30-day time-period, you shall have the right to opt-out from your Tariff Plan by informing us of your decision to this effect without incurring any penalties for early termination of your Tariff Plan, as may be applicable. Your continued use of the service after the expiration of the 30-day time-period signifies your acceptance of any amendment.

**11.3** From time to time we may modify the standard settings and/or features of your Plan to offer an additional value. Such changes might include increasing your data or

improving your connectivity speeds. In case that such changes are approved and considered to be inherently beneficial by the Malta Communication Authority in accordance with applicable laws, we will inform you about the changes by giving you a 1-day prior notice and term 11.2 above will not apply.

**11.4** If you are using a Blackberry® Easyphone, you need to subscribe to a Blackberry® license fee of €2, inclusive of VAT payable every 30 days. This license fee will allow you to access internet from your Blackberry device. To purchase the Blackberry® license fee, you must send a free SMS to 16200 with the word 'BB'. Upon purchasing the license fee, you shall automatically be charged €2 every 30 days, which amount will be deducted from your mobile credit. Should you wish to stop purchasing the Blackberry® license fee, you must send a free SMS to 16200 with the word '**STOPBB**'.
